## Administration Meeting:

Business Licenses –

  approved.
- Gordon Home Addition The commissioners could see no issues with the addition. John Davidson made a motion to approve the home addition. Nancy seconded the motion. The home addition was approved.
- Top Job They were not present. Kevin Wright had a few questions about this property and the other commissioners and Jill Pack updated him where things stand right now with their property development. Right now P&Z is waiting on the Miles to show proof of a well and the deliverability of water.
- Ordinance Changes/Review Update Jill Pack had emailed the current conditional use permit application to the commissioners before the meeting. John Davidson stated that the conditional use permit application looks good and that it seems to do what the commission is trying to do by giving more control to the city when new commercial businesses come to Mendon. This would allow the city to set certain requirements and standards for each business individually on a case by case basis. Kevin Wright stated that sometimes that can be hard if everything is in writing because not everything can be listed so something may be missed. Bob Jepson stated that the City is getting closer to having the city ordinances codified so this is a good time to review the ordinances and make the changes that are needed.
